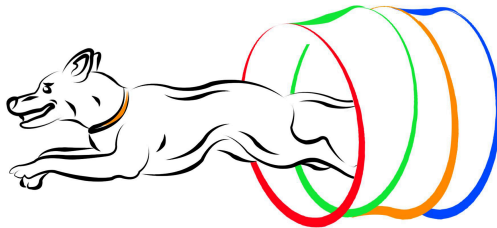

The exhibitor is fully responsible for entering the dog in the correct class(es)/height divisions. Dogs running in a lower height division than they are eligible for will be eliminated.

### MEASURING and HEIGHT CARD INFORMATION

Effective January 1, 2010, exhibitors are no longer required to provide proof to Trial Secretaries that their dog has a valid jump height card as part of the check-in process. Furthermore, this change eliminates the need for a copy of the jump height card to be submitted with an entry form. Dogs without a valid Jump Height Card/Form may still compete; but they must be measured/wicketed by the **Judge of Record** PRIOR to running in their class and this measurement will be valid for that weekend of trials only. The exception to this requirement is a dog entered in the 24" or 26" height division. However, if a **Volunteer Measuring Official (VMO)** or an **Agility Field Rep** is present; **ALL** dogs without a valid Jump Height Card/Form must be measured at some time during the trial or cluster of trials. This does not preclude having the dog wicketed by the Judge of Record if the VMO or Rep is not available to measure the dog *before* its first run of the trial or cluster of trials. It is the exhibitor's responsibility to have their dog measured prior to running and failure to do so will result in the cancellation of any qualifying scores.

### Simplified Jump Height Card Process

When filling out the entry form, there is a new section at the top of the form for exhibitors to designate whether your dog needs to be officially measured. Please check the box so that the Trial Secretary knows whether to include your dog on the *Dogs To Be Measured List*. It is no longer required that you submit a copy of your dog's jump height card with your entry form or show it during day of show check-in.

### DOG ELIGIBLE TO ENTER

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), **an AKC Canine Partners listing number**, or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations it includes both sexes.

Dogs should be physically sound. Dogs that are blind shall not be eligible, and neither are bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registerable breeds that may participate. Puppies under four (4) months of age are strictly prohibited from the trial grounds.

**Illegible entries** will not be processed. Returned checks do not constitute a valid entry and the Trial Secretary will add a **\$35** collection fee to the amount of each returned check.

Entries close December 6th, 2019 at 6:00pm MST after which time entries cannot be accepted, cancelled, altered, or substituted except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows.

A maximum of 10 entries per envelope. Envelopes/transactions containing entries for more than the ten (10) dog maximum and/or entries received prior to the opening date shall be treated as an invalid entry and shall be returned to the sender.

## WAIT LIST INFORMATION (if offered)

Mesa Arizona Agility Club is offering a wait list to fill openings created by withdrawn entries after the trial's closing date/time. A maximum of 15 entries will be placed on the club's wait list. All entries, including wait listed entries, must be received by the Trial Secretary prior to the event's closing date and time as posted on the Premium List cover. Any entries withdrawn that are received by the move-up date and time as posted on the Premium List cover will be replaced by a wait listed entry if any are available. If a withdrawn entry is replaced by a wait listed entry, a full refund will be issued for the withdrawn entry. Any wait listed entry that does not move off the wait list into the trial by the move-up date and time as posted on the Premium List cover will receive a full refund.

## COURSE WALK-THROUGHS AND WARM-UP INFORMATION

Handlers in all classes are permitted to walk the course, without a dog, during a walk-through period held prior to the start of the class. The walk-through is restricted to handlers entered in that class only. Handlers with multiple dogs, at events with multiple rings may request to walk with a height group other than the one their dog is entered in if a conflict is imminent.

A warm-up area, consisting of a regulation agility jump, may be provided for exhibitors. The warm-up area is to be used exclusively for warming up the dog and not for training or relieving of the dog.

## OBSTACLES AND RING CONDITIONS

Obstacles will meet the specifications for obstacles in the current edition of the Regulations for Agility Trials. All classes will take place outdoors on a grass surface. Ring size will be 110' x 120'.

## ADDITIONAL SITE INFORMATION

### A REQUEST FOR HELP

Club members and local exhibitors are encouraged to assist with pre-trial setup and post-trial breakdown. Pre-trial show setup will be 11:00 AM MST on Thursday, November 28th, 2019.

### UNLOADING & SETUP

Setup is between 2:00 PM – 4:00 PM on Thursday, December 19th, 2019 and after 7:00 AM MST on Friday, December 20th, 2019.

For the safety of people, dogs, and property, please be sure to stake or weight your setups. Wind can arrive at any time, unexpectedly. Be sure to bring shade for your dogs. Bring plenty of drinking water. For RVs there is no power, bring generators.

### HOSPITALITY

Beverages and snacks will be provided to all workers. There will be no food vendor at this trial, however, there are an abundance of food options less than two (2) miles from the trial site. The club will also be providing lunch for volunteers.

### VENDORS

Unfortunately, the Town of Queen Creek does not allow vendors at our site. However, photographers are welcome as long as they don't sell their photos on site.

## RIBBONS, AWARDS, AND PRIZES

Ribbons will be awarded to the 1st through 4th place dog in each jump height class. A qualifying ribbon will be awarded to all dogs receiving a qualifying score. A New Title rosette will be awarded to all dog and handler teams finishing a title. A MACH or PACH rosette ribbon and jump pole will be awarded to anyone completing these titles. All prizes, awards, and ribbons must be picked up before the end of the show. No ribbons, etc. will be mailed after the show. \* Achievement Ribbons and Awards are subject to change without prior written notice in this Premium List.

## NOTICE TO EXHIBITORS

### SAFETY, BEHAVIOR and LIABILITY

The **safety of the dog** is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.

**It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or

disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. Mesa Arizona Agility Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The **Mesa Arizona Agility Club** reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the **Mesa Arizona Agility Club** or any official thereof.  
**All dogs must be on leash** at all times when on trial grounds except when in the designated warm-up area or competing on the course.

## REFUNDS

**No entry fee** will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

**Bitches in season** are not permitted to compete in Agility Trials. Bitches in season are not allowed on the show grounds. Entry fees will be refunded in full for bitches that come into season after the closing of the trial provided the following conditions are met: The Trial Secretary receives WRITTEN notice of withdrawal no later than 30 minutes prior to the start of the event on the first day. A veterinary letter is provided to the Trial Secretary within 48 hours of the conclusion of the show.

After the closing date entries cannot be accepted, cancelled, altered, or substituted except as provided for in Chapter 1, Section 21 and Chapter 11, Section 6 of the Rules Applying to Dog Shows.

Review your entry. You will be sent an Entry Received email close to the date your entry is received, and after close, an Entry Confirmation email. This is your only opportunity to notify the Trial Secretary of errors.

Returned checks do not constitute a valid entry. The Club may add a \$35.00 collection fee to the amount of each returned check, and exhibitor will be put on a "cash only" basis.

Decline of entries: The Club may decline any entries for cause and may refuse to receive, or may remove, any dog on account of disease, viciousness, or other cause, and no one shall have any claim or recourse against the Club, or any official thereof.

## RINGSIDE

**Dogs may arrive** any time prior to judging if the dog has a valid temporary or permanent jump height card. Otherwise, they must be available for measuring prior to the start of their class if a VMO or AKC Field Rep is available to measure dogs. All dogs not needed for further judging will be excused.

**Judges are not required** to wait for dogs. The Owner of each dog is solely responsible for having it ready at ringside when it is to be judged. The Club has no responsibility for providing service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

**This club agrees to arbitrate claims as set forth on the Official AKC Entry Form for this event.**

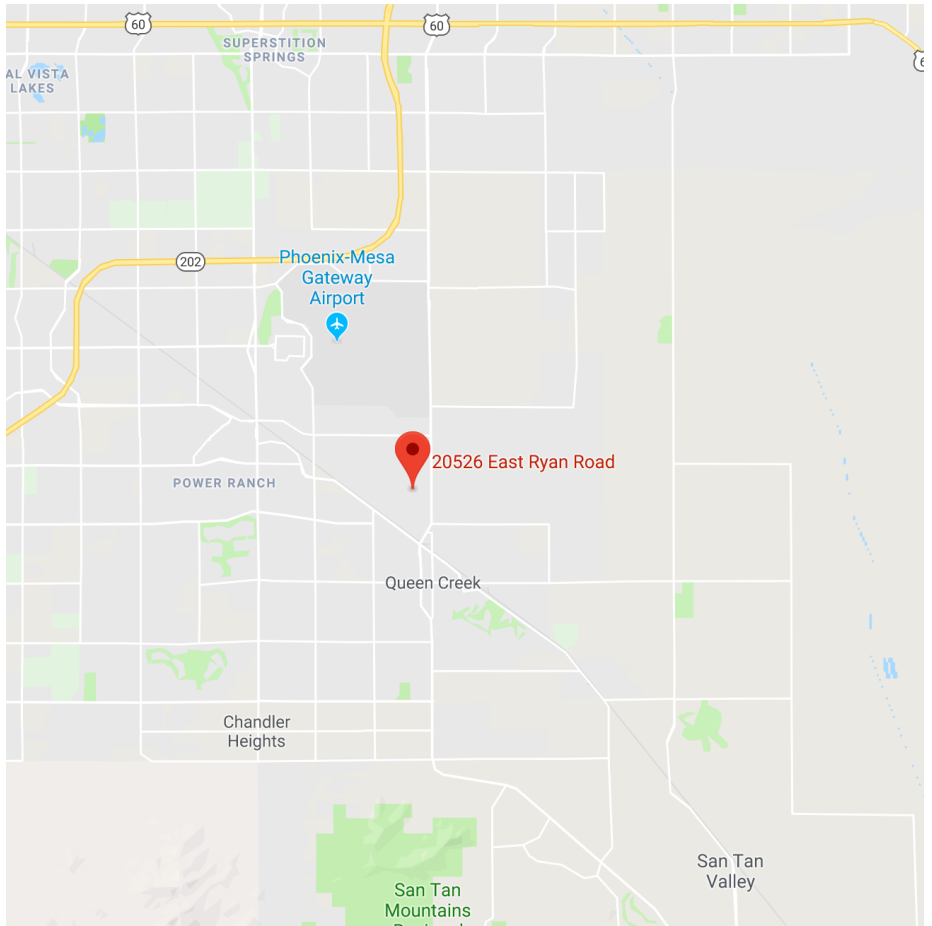

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other person. I (we) agree that the determination of whether the injury is serious shall be made by the event veterinarian and is binding on me (us). I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND THE EVENT-GIVING CLUB (UNLESS OTHERWISE STATED IN THIS PREMIUM LIST) AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. HOWEVER, PRIOR TO ARBITRATION ALL APPLICABLE AKC BYLAWS, RULES, REGULATIONS AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, RULES, REGULATIONS, PUBLISHED POLICIES AND GUIDELINES.

## INSTRUCTIONS

Handlers may opt to enter in a higher **height division** for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs entered in the **Preferred** classes **must** compete at the required jump height and **may not** compete in a jump height **division higher or lower** than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or *back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the **AKC Canine Partners Program**<sup>SM</sup> may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

**Junior Handlers** should enter their Junior Handler Number on the front of this form.
